The Institute is authorized by the Directorate General of Shipping (DGS) and Directorate General of Civil Aviation (DGCA), Government of India for the testing of bulk packages for the carriage of hazardous goods for exports by Sea and Air respectively.

In addition to the above, the Institute also conducts Collaborative; In- Plant / Company Oriented Programmes and In-Laboratory Hands-On Trainings in the field of Packaging.
